

## TANKNETICS SIR SERVICE AGREEMENT

**AS PER,** use of the forms provided by and sending data to Tanknetics SIR through any means, implies that you understand and agree to the terms of this Service Agreement though a signature is not required.

WHEREAS, TANKNETICS SIR, LTD has developed a computer software program for use as a method of Underground Storage Tank Monthly Monitoring and Leak Detection and Integrity Testing of Tank and Lines utilizing the Statistical Inventory Reconciliation (SIR) method of inventory analysis, as permitted by the U.S. E.P.A., State and Regional regulatory agencies; and

WHEREAS, TANKNETICS SIR, LTD Statistical Inventory Reconciliation method has received third party certification using the U.S. E.P.A's "Standard Test Procedures for Evaluation of Leak Detection Methods: Statistical Inventory Reconciliation Analysis System", E.P.A. I53O/UST-90/007, June 1990 and U.S. E.P.A. NWGLDE's protocol addendum "Protocol for Determining Applicability of a SIR Method for Manifold Tanks and Determining Limitation". November 14, 1996; and

**WHEREAS**, the CLIENT wishes to use Tanknetics SIR, Ltd. services based on the TANKNETICS Statistical Inventory Reconciliation Analysis System, hereinafter **Tanknetics**, subject to the terms and conditions outlined herein.

#### THE PARTIES HERETO AGREE AS FOLLOWS:

- 1. Client agrees to provide Tanknetics SIR, ltd. With accurate and correct tank data in a timely manner in order to provide accurate and timely results as required by the EPA and State environmental agencies.
- 2. Fees for services rendered are due 30 days from the receipt of reports. Fee schedule is attached at the bottom of this document. All late payments are accessed a 20% late fee after a 10-day grace period from the due date.
- 3. Client and Tanknetics agree to mutually protect one another in a non-disclosure agreement implied in this agreement.
- 4. Client agrees to hold harmless Tanknetics SIR Ltd, it's staff, heirs and partners and indemnify all of the above against all actions, causes, losses, penalties and fines related to or arising out of this relationship.
- 5. Client understands that the Tanknetics software is capable of producing the following results as provided by the EPA and third-party verification; PASS, FAIL, INCONCLUSIVE.
- 6. This agreement shall be interpreted in accordance with the laws of the State of Pennsylvania, Butler County.
- 7. Should any part of this agreement become or be held to be invalid, the remaining portions shall remain in full force and effect.
- 8. Client agrees that by submitting data, with the intent to receive SIR reports that this agreement is in effect without signatures.
